A formal demand letter to a person of business for money owed is a detailed letter demanding payment of a debt or money owed in an amount of FIVE-THOUSAND DOLLARS (\$5,000.00) or less. It may seem "to good to be true," that a formal letter to your debtor which effectively conveys your demands and intentions to pursue the matter in small claims court if the issue of non-payment persists or is not satisfied, could actually result in the debtor paying what is owed to you; however, this could be the result!

There are a few key benefits to sending a formal demand for payment in collecting any debt, including the following:

- ✓ It shows the non-paying party that you're serious about collection
- ✓ It will help support your claim should you need to file a small claims action with the courts
- ✓ It will preserve your interest in all collection related matters (i.e. starts clock for charging interest)
- ✓ It may qualify you for extra legal remedies (i.e. to collect penalties or costs attributable to your legal action)
